





In recognition of the Congregational Way, and in accordance with the Constitution and By-laws of Sawyer Memorial Congregational Church, our pastoral search committee conducted several interviews with Phyllis W. Merritt to familiarize themselves with her academic credentials, her training, her character, her theology, and her commitment to service as a Congregational Christian Minister before presenting her to us as their recommended candidate.
